The "One Year Amounts" and "Three Year Amounts" required to be disclosed are both zero with respect to the 2022 distributions, since all capital gain dividends relate to Section 1231 gains.

The Company did not incur any foreign taxes in 2022. The December 2022 monthly common stock dividend that was declared on October 12, 2022, and paid on January 17, 2023, of \$0.121667 per share will be considered a dividend attributable to 2023 for U.S. federal income tax purposes.
